#### **DESCRIPTION:**

Inmates are authorized to purchase items as listed in Inmate Property Matrix dated 1/23/2023.

- 1. Items of personal property may be purchased from approved vendors by third parties of the inmate.
- 2. Inmates scheduled for parole or waiting discharge may be sent a release package no earlier then 30 days from their scheduled parole or discharge date.

3. A Mike's Better Shoes representative works directly with the R&R Sgt. to determine what products are allowed at the facility. All items listed in our catalog have been pre-approved by the central administration in Sacramento. Mike's Better Shoes makes every effort to keep up-to-date on the rules & regulations of the participating facilities. It is important to remember that institutions are not uniform and that requirements change from time to time. If you have any questions regarding package rules, please contact the facility or call us at 856-767-1300.

#### POLICY:

- 1. Shower shoe: Foam or soft rubber. Single layer. Not to exceed 1" in thickness
- 2. Tennis or Walking shoes: Stays the same
- 3. Clothing (Athletic Shorts, T-Shirts, Socks, Hats, Briefs, Boxers, Boxer Briefs Sweats etc.) White or Light Gray is permitted.
- 4. Athletic Shorts: No inside pockets. A single pocket is authorized providing the opening is visible.
- 5. Shoelaces: White only. 54" maximum. One for one exchange.
- 6. Slippers or House Shoes: No Leather or leather like. White or light gray only.
- 7. Socks: No stripes, design or logos. Short to Knee High.
